### **1. Introduction**

Our website, <u>https://www.alifs.fr</u> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). ### 2. What are cookies?

#### 6.1 Technical or functional cookies
